FIXING THE COURT STARTS WITH OUR VOICES: **CALL YOUR MEMBERS TODAY**

Congress has the authority to fix the Supreme Court if its Members are bold enough to act. We, the people, have power in our collective voice and those entrusted with representing us have a responsibility to listen.

Now is the time to hold our Members of Congress accountable to standing up to the MAGA supermajority with bold commitments to **fix the Court**.

- I am a constituent in [state] and I am calling to let you know that I oppose the broken and corrupt Supreme Court's *relentless* power grab – and I am calling on you to step up and do something about it.
- The MAGA justices have already taken away our reproductive freedoms, weakened our right to vote, made it easier for corporations to pollute the air we breathe and water we drink, and made it harder to keep our communities safe from gun violence. All to help the ultra rich and powerful, who finance their luxury vacations and private jet flights, get richer and gain more power.
- Now, the same, corrupt MAGA justices could rule in a series of cases, including *Relentless Inc. v. Department of Commerce*, to give themselves even more power to rewrite the rules in favor of special interests, billionaires, and major corporations — and again at our expense.
- As a Member of Congress, you have a choice to make: Stand up to the MAGA power grab on behalf of the people you were entrusted to represent OR enable the justices' ongoing harm to your constituents.
- I will not support you unless you stand up to the MAGA power grab. And I'm not alone – more and more people are learning about this Supreme Court's *relentless* power grab, and we're sick and tired of it.

If your Members of Congress stand with the people AGAINST the MAGA Supreme Court, let them know you stand with them and urge them to keep up the fight.
